

Liability Waiver (including COVID-19 Liability Waiver)

This Liability Waiver Form must be completed and signed *(by check the box on the registration Check Out page)* by the parent or guardian for the enrolled student ("STUDENT") before participation in **The American Chinese School of Greater Detroit** ("ACSGD") instructional programs ("PROGRAM").

In consideration for receiving permission to enroll and participate in **ACSGD**, I hereby:

1. Acknowledge, agree and represent that the undersigned enters this agreement freely and voluntarily with all information fully disclosed by **The American Chinese School of Greater Detroit**.
2. Acknowledge the contagious nature of the Coronavirus/COVID-19 and that **ACSGD** has put in place preventative measures to reduce the spread of the Coronavirus/COVID-19. I further acknowledge that **ACSGD** can not guarantee that I will not become infected with the Coronavirus/Covid-19.
3. Fully understand, as parent(s) or legal guardian of the aforementioned student(s), who will attend SCHOOL during the current academic year in the aforesaid PROGRAM, that my child(ren)'s participation in the PROGRAM involves risk of accidents or personal injuries, as well as increases the risk to exposure to the Coronavirus/COVID-19. Therefore, on behalf of my child(ren), my spouse/partner and myself, the undersigned has hereby agreed to release, waive, discharge and covenant NOT to sue and to hold harmless **ACSGD**, its board members, teachers, contractors, volunteers, administrative officers, employees and any other associated personnel including owners or landlords of the premises utilized by **ACSGD**, of and from any and all claims, actions and damages for accidents, personal injuries, emotional distress, disabilities or death that my child or any of my family members have or may have sustained as a result of participation in this PROGRAM.
4. Further agree to take full responsibility for my child(ren) to observe, follow and obey any and all SCHOOL rules. I and my child(ren) will also follow all CDC recommended guidelines as much as possible and limiting the exposure to the Coronavirus/COVID-19.
5. In the event that the undersigned should observe or discover any unsafe personal conduct or unsafe physical condition on the premises of **ACSGD**, the undersigned has agreed to report the unsafe conduct or condition to **ACSGD** representative as soon as possible.
6. By registering for in-person classes, the undersigned attest that:

- 1) **My child(ren) is(are) not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.**
 - 2) My child(ren) has(have) not traveled internationally within the last 14 days.
 - 3) My child(ren) has(have) not traveled to a highly impacted area within the United States of America in the last 14 days.
 - 4) I do not believe my child(ren) has(have) been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19 in the last 14 days.
 - 5) My child(ren) has(have) not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non contagious by state or local public health authorities.
7. This acknowledgment of risk and waiver of liability, having been read thoroughly and understood completely, is signed voluntarily as to its content and intent.
